



## **Extractive industry: Identifying programmatic opportunity for Oxfam in Mozambique workshop.**

**Date: 14-15 March, 2013**

**Location: Maputo**

### **I. BACKGROUND AND CONTEXT**

The Oxfam Mozambique Country Strategy 2012-2016 identifies the need to respond to the growing influence of the private sector. This is particularly relevant to the rapidly expanding extractives sector.

The Strategy identifies the importance of a strong and informed civil society to influence both government policy and company practice, particularly with regard to access to and control of land and natural resources, tax justice, and budget monitoring. It recognises poor and marginalised women do not always participate in development decisions to ensure their resource rights.

### **II. OUTLINE OF THE WORKSHOP**

The two day workshop will be an opportunity for Mozambique civil society organisations, partners and international NGOs to:

- 1) Contribute to identify programmatic opportunity for Oxfam in MozambiqueBuild a shared understanding of the Mozambique extractives context
- 2) Build a shared understanding of local & global mining issues (resettlement, revenue transparency, FPIC, gender impacts, access to remedy)
- 3) Identify opportunities and alliances to support active citizenship and gender justice in mining governance and project decision making
- 4) Identify opportunities to progress engagement with and influence of large companies such as Vale, Rio Tinto, Gindal, Andarko and ENI.

At the end of the workshop it is intended that Oxfam and partners will be in a position to identify the programmatic areas related to extractive industry that will 'add-value' to the current programs and initiatives in Mozambique.

#### **2.1 Goal**

This workshop aims to facilitate a shared understanding of the impacts of mining on communities, and opportunities to link global responses to the Mozambique context. The aim is to use the discussions and ideas as the basis of the Oxfam program design.

#### **2.2 METHODOLOGY**

The workshop will have a focus on discussion and information sharing. It will include some presentations, but power points will be kept to a minimum. The workshop will draw on the experiences



of participants and include thematic discussion on issues including: resettlement, revenue transparency, gender, FPIC, and access to remedy.
