Relatório Situação Mundial da Infância 2012: "As Crianças em um mundo urbano"

Fundo das Nações Unidas para Infância

O Relatório Situação Mundial da Infância é a principal publicação global do UNICEF que trata das principais questões e desafios que afectam as crianças do mundo. Para o ano 2012 o relatório foca as crianças que vivem em meio urbano. O estudo revela que mais de metade da população mundial, incluindo crianças, vivem actualmente em cidades e vilas, e que enquanto muitas crianças têm os benefícios das cidades associados a oportunidades de acesso a escolas, hospitais e parques infantis, centenas de milhões doutras vivem marginalizadas sem acesso ao registo de nascimento ou a esses serviços sociais. O relatório constata o risco que estas crianças enfrentam, e define os passos necessários para criar cidades próprias para crianças. Neste contexto, as crianças que vivem nos subúrbios, os filhos de migrantes e deslocados, crianças sem registo formal e pessoas vitimas de tráfico estão entre os mais vulneráveis, visto que na maioria das

áreas urbanas coexistem grandes oportunidades e grandes privações. Para o caso de Moçambique o relatório enfatiza que a população que vive em áreas peri-urbanas não tem acesso a instalações sanitárias adequadas, e é uma das mais pobres e vulneráveis da sociedade, pois não possui rendimentos estáveis para garantir a sua sobrevivência.

O relatório recomenda que a criança deve ser colocada em primeiro lugar a fim de assegurar que todas, tenham as oportunidades que necessitam para realizar seus direitos e que medidas urgentes devem ser tomadas para melhor compreender a dimensão e natureza da pobreza e da exclusão que afectam as crianças nas áreas urbanas, de modo a assegurar que o planeamento urbano, desenvolvimento de infra-estruturas, prestação de serviços e esforços mais amplos para reduzir a pobreza e a desigualdade atendam as necessidades específicas e prioridades das crianças.

Custos Socio-Económicos da Violência contra a Mulher em Moçambique

O estudo apresenta os resultados duma pesquisa efectuada nas cidades de Maputo, Matola, Beira e Nampula. O estudo descreve e quantifica os custos sócio-económicos da violência contra a mulher no seio da família e da sociedade, e,

demonstra o quão avultados são os recursos públicos e privados mobilizados no atendimento as consequências desta prática. Do ponto de vista social, o estudo argumenta que, os custos da violência contra a mulher prejudicam não só a esta, mas também aos filhos e aos próximos. Estes prejuízos compreendem a destruição da auto-estima e segurança da mulher, destabilização psicológica dos filhos e a perturbação do lazer e conforto dos próximos. Como consequência, a produtividade da mulher, o rendimento escolar e profissional dos filhos são baixos em relação às suas reais potencialidades.

Do ponto de vista económico, os autores estimam que o custo da violência contra a mulher é de 44.214.861,95 meticais, dos quais o sector da saúde absorve 81%, a justiça 17%, e as associações que trabalham na área de prevenção e combate à violência doméstica 2%. Em consequência deste resultado, o estudo constata que a violência contra a mulher desvia a atenção e a concentração dos recursos humanos no trabalho, estudos, lazer e convívio, bem como dos recursos financeiros necessários à construção material e cultural, o que inviabiliza os esforços de desenvolvimento individual, familiar, comunitário, estatal e da sociedade em geral.

Em conclusão, e como forma de combater a violência contra a mulher, o estudo recomenda e propõe a tomada de medidas na área da educação e outras, com o objectivo de capacitar a sociedade a perceber os prejuízos da violência contra a mulher, e necessidade da alteração do cenário desta violência, prevenindo-a desde a tenra idade nas várias esferas da sociedade.
