#### **Relatório do Desenvolvimento Humano 2011**

#### **Sustentabilidade e Equidade: Um Futuro Melhor para Todos**

#### **Programa das Nações Unidas para o Desenvolvimento**

O Relatório do Desenvolvimento Humano de 2011 oferece contributos para o diálogo global sobre a justiça distributiva nas duas vertentes: intergeracional, ligada a sustentabilidade ambiental, e intrageracional, ligada a equidade, mostrando como a sustentabilidade está indissociavelmente ligada à equidade. As previsões sugerem que o insucesso na redução dos riscos ambientais graves e as crescentes desigualdades ameaçam abrandar décadas de progresso sustentado da maioria pobre da população mundial. O relatório defende que o progresso no desenvolvimento humano não pode continuar sem passos globais arrojados para a redução dos riscos ambientais e da desigualdade.

O relatório constata que as políticas de exploração insustentável dos recursos contribuíram para aumentar a desigualdade do Índice de Desenvolvimento Humano, e que

o agravamento da desigualdade do rendimento tem neutralizado melhorias significativas no campo da desigualdade na saúde e na educação. A distribuição de rendimento piorou ao longo dos últimos 40 anos, e a degradação ambiental ameaça as perspectivas futuras, suportando as pessoas mais desfavorecidas um “duplo fardo”: da privação do rendimento e da privação ambiental. O mercado livre por si não responde às questões ambientais, nem distributivas, por isso as constatações exigem um profundo repensar sobre o papel do Estado. Ainda que sendo focado em questões ambientais e nas comunidades, o estudo reflecte um reconhecimento crescente, ou redescoberta, da necessidade de políticas e intervenções pró-activas do governo como meio de reestruturar a economia.

#### ***El dorado Tete: os mega projectos de mineração***

#### **João Mosca e Tomás Selemane**

Esta publicação recente do Centro de Integridade Pública procura responder a uma questão actual na sociedade moçambicana: que benefícios locais provêm dos mega projectos? Os mega projectos (os empreendimentos que têm recebido investimentos iniciais não inferiores a quinhentos mil dólares americanos) destinados ao sector mineiro-energético dominam a economia moçambicana nos últimos anos. Entretanto, devido aos incentivos fiscais, às excepcionalidades legais e as facilidades de operação concedidas, a sua contribuição fiscal é bastante reduzida. É neste contexto que os autores realizaram o estudo sobre os efeitos dos

mega projectos de mineração nas cidades de Tete e Moatize, procurando analisar os impactos para além do impacto fiscal das duas multinacionais instaladas na região. O estudo analisa o efeito sobre os principais sectores económicos locais, os fenómenos migratórios e o mercado de trabalho, as infra-estruturas, a inflação local e a governação. Os reassentamentos das populações nas áreas de mineração e a questão ambiental mereceram também atenção neste trabalho.

O estudo conclui que apesar dos mega projectos de mineração da Vale e Riversdale induzirem novas dinâmicas ao nível local, o seu impacto é socialmente discriminatório, criando um padrão de crescimento não inclusivo e com sinais de aprofundamento de pobreza. No nível de governação, a não transparência dos contratos entre o Governo central e as multinacionais abre espaço para corrupção, e a descentralização não está ser acompanhada pela capacitação e envolvimento efectivo do governo local no processo das decisões, provocando uma assimetria da capacidade técnica e de poder de decisão entre as multinacionais e o governo local.
